Minutes of the Parish Council Meeting

held at Shirland Village Hall on Thursday 23rd February 2023 at 7.00pm

01/02/23 To consider accepting apologies for absence:

Apologies were received and accepted from Cllr Michelle Green, Cllr Mike Roe and Cllr Charlotte Cupit.

02/02/23 Declarations of Interest from members on any items to be discussed:

Cllr B Barnes – Trustee Fidler and Laverack, volunteer for Stonebroom Community Volunteer Group, Stonebroom Food Pantry and the Holiday Activities and Food Group. Cllr D Williamson – Trustee Fidler and Laverack. Cllr A Brown, Cllr J Bacon and Cllr G Mather – Management Committee of Shirland Village Hall.

03/02/23 To receive and approve requests for dispensations from members on matters in which they have a Disclosable Pecuniary Interest:

None.

04/02/23 To determine if any item on the agenda should be taken with the public excluded: None.

05/02/23 To consider for approval the minutes of the Extraordinary Parish Council Meeting held on Thursday 2nd February 2023:

Cllr B Barnes proposed and Cllr G Mather seconded that the minutes be approved.

06/02/23 Residents or public questions/comments (A period of not more than 15 minutes is allocated for members of the public and councillors to comment on any matter relating to the Parish):

A member of Stonebroom Community Volunteer Group spoke about the recent report submitted to the Parish Council and asked if Councillors would re-consider the decision to remove logs from the woodland following the tree works.

07/02/23 To consider the information provided by Jonathan Tipton from Bolsover District Council and agree the venues for the 2023 Extreme Wheels sessions:

Cllr J Bacon proposed, Cllr A Brown seconded and it was unanimously agreed that the Easter sessions will be held at Mickley and Stonebroom. The May half term session will be held at Shirland and during the summer holiday period two sessions will be held in each of the three villages. The venue for October half term will be decided later in the year.

During this item Standing Orders were suspended for a short while to allow a member of Stonebroom Community Volunteer Group to speak.

08/02/23 To consider the appointment of the Internal Auditor:

Cllr D Williamson proposed, Cllr J Bacon seconded and it was unanimously agreed that Joanne Taylor be asked to carry out the audit.

09/02/23 To consider the fees and charges for 2023/24:

Cllr A Brown proposed, Cllr B Barnes seconded and it was unanimously agreed that all fees will remain the same.

10/02/23 To consider the maintenance of The Triangle in Shirland:

Cllr A Brown proposed, Cllr A Lomax seconded and it was unanimously agreed that the offer made to Shirland Country Club be withdrawn and the Parish Council's Grounds Maintenance Contractor be instructed to carry out the grass cutting. This decision was necessary as the agreement sent to the Country Club last summer has not been signed.

11/02/23 To consider the information received from Derbyshire County Council regarding the diversion of Public Footpath No. 25:

Cllr A Lomax proposed and Cllr D Williamson seconded that the Parish Council reluctantly withdraw their objection. A vote was taken with eight Councillors for this decision and two against.

12/02/23 To consider the purchase and installation of an additional noticeboard for Stonebroom: Cllr J Bacon reported that she had recently met with a representative from Mainstream Meats regarding siting a new noticeboard on their land. Cllr A Brown proposed, Cllr D Williamson seconded and it was unanimously agreed to order a new noticeboard providing Mainstream Meats sign an agreement.

13/02/23 To consider the purchase and installation of two additional war memorials in the Parish: Deferred until the March 2023 meeting.

14/02/23 To consider the correspondence received regarding highway issues at Town End Shirland:

Cllr H Liggett proposed, Cllr D Williamson seconded and it was unanimously agreed that the Clerk writes to Derbyshire County Council stating that the Parish Council feel that it would be favourable to turn the road into a one-way street.

Cllr J Bacon, Cllr A Brown and Cllr G Mather left the room and Cllr H Liggett took the Chair.

15/02/23 To consider the repairs required to the roof at Shirland Village Hall:

Cllr H Liggett proposed, Cllr D Williamson seconded and it was unanimously agreed that Chambers and Partners are contacted to arrange a structural report.

Cllr J Bacon, Cllr A Brown and Cllr G Mather returned to the meeting.

16/02/23 To consider the works required to the seat at Mickley Scooter Park:

Cllr B Barnes proposed, Cllr H Liggett seconded and it was unanimously agreed to install a concrete base for the seat.

17/02/23 To consider the proposal from the Stonebroom Community Volunteer Group to use Stonebroom Pavilion and Sportsground for a picnic on the 7th May 2023:

Cllr A Lomax proposed and Cllr H Liggett seconded that permission be granted. This was unanimously agreed with the exception of Cllr B Barnes who did not vote due to an interest declared at the beginning of the meeting.

18/02/23 To consider the report on Ash dieback received from the Stonebroom Community Volunteer Group and the request for logs to be left at the Woodland following the tree works:

Cllr B Barnes proposed, Cllr G Mather seconded and it was unanimously agreed to leave the logs on site.

19/02/23 To consider the request from the Stonebroom Community Volunteer Group for litter piking hoops:

Cllr D Williamson proposed, Cllr A Brown seconded and it was unanimously agreed to purchase twelve hoops.

20/02/23 To consider the request from Stonebroom FC for the football pitch to be rolled:

Cllr A Brown proposed, Cllr B Barnes seconded and it was unanimously agreed to obtain one more quote and then go with the cheapest.

21/02/23 To consider using the Spirit of Alfreton community news website:

Cllr J Bacon proposed. Cllr A Brown seconded and it was unanimously agreed to use the website.

22/02/23 To consider the A61 Speed Limit Review initial consultation:

Cllr H Liggett reported that she is working with the Planning Enforcement team regarding the former Crown Inn Public House and the former Shirland Church Hall.

Cllr H Liggett is working with North East Derbyshire District Council to try and increase the frequency of footway sweeping in the Parish.

Cllr H Liggett mentioned that the Chair of North East Derbyshire District Council is holding a Race Night on the 17th March 2023.

26/02/23 Reports from Councillors on outside bodies and community groups:

Cllr B Barnes reported that Stonebroom Community Volunteer Group had recently carried out a successful litter pick in the village and are arranging Easter events in the Woodland. The Holiday and Food Group have obtained funding for Easter and Summer events and are holding a quiz night in March. Cllr Barnes reported that the Food Pantry will be opening soon.

27/02/23: Report from Chair:

The Chair reported that she had attended a meeting of the Community of Shirland and Higham Group who are arranging a Barn Dance at Shirland Village Hall on the 25th March 2023. Future events were discussed at the meeting and the committee are looking for new members to join them on the group. Cllr A Brown had also attended a meeting of Shirland Village Hall Management Committee. She reported that a bouncy castle and more new chairs have recently been ordered. An event will be held at the hall on Monday 8th May 2023 for the King's Coronation. The Chair spoke about regular successful events that take place in the hall.

28/02/23 Report from Clerk:

NEDDC are holding a public meeting at Shirland Village Hall on 2nd March 2023 regarding the Stonebroom Community Governance Review. All households in the Parish will be receiving information on this in the next couple of days. At the March Parish Council meeting the Community Governance Review Working Group are attending to speak to Councillors.

At the January meeting a member of the public spoke about the condition of a footpath surface in Stonebroom. DCC's footpath officer has carried out an inspection and found that the surface is not problematic and doesn't justify expenditure.

The new play equipment will hopefully be installed by the end of March.

The new kitchen at Shirland Village Hall is to be installed at the end of March.
