01/01/21 To consider accepting apologies for absence:

05/01/21 To consider for approval the minutes of the Parish Council Meeting held on Thursday 15th October 2020:

Cllr A Lomax approved and Cllr G Liggett seconded.

06/01/21 Residents or public questions/comments (A period of not more than 15 minutes is allocated for members of the public and councillors to comment on any matter relating to the Parish):

Cllr A Brown informed the meeting about the recent increase in dog thefts. Posters are to be put up in the noticeboards and on the website encouraging owners not to leave dogs unattended.

Jude Milburn from Rykneld Homes and Libby Hawkins spoke about proposals for the Mickley BMX track including the setting up of a club and coaching sessions.

It was unanimously agreed that meetings will be held on the 3rd Thursday of every month with the exception of December. Cllr M Roe suggested an earlier start time of 6.30pm particularly whilst the meetings are being held remotely, this will be discussed at the February 2021 meeting.

10/01/21 To consider the confirmation of the Caretaker's employment following the end of the probationary period:

Shirland and Higham parishioners currently benefit from immediate access to the countryside surrounding our village for local recreational walks, dog exercise etc in the green and pleasant surroundings that the panoramic vistas and tranquillity of quiet and space together with the local public footpath network offers. Indeed, yet more housing is planned to be built close to this site, and as a consequence, demand for access to open countryside is more crucial than ever.

Whilst we are not opposed to the installation of renewable energy generation, we feel that this application, particularly when aggregated with the concurrent application which borders it and covers Hall Farm and Ufton Fields Farm (which is even larger) has a magnitude of change to the character of the area that is immense when one considers that the solar panels will be mounted on frames up to 3m high, surrounded by tall fencing of a style that is incongruous with cctv cameras mounted at 150m intervals. This will have a consequence of altering our landscape from rural to an industrial setting for a period of 40 years. This would have a major impact on the visual amenity we all currently enjoy in this area and will occur over a long duration.

The Parish Council are very disappointed with the lack of public consultation which has taken place prior to the submission of this application.

Another point the Council wish to raise is there doesn't appear to be any mention of any Section 106 contribution to compensate the community for the impact of the development.
