Minutes of the Parish Council Meeting

held at Shirland Village Hall on Thursday 19th January 2023 at 7.00pm

01/01/23 To consider accepting apologies for absence:

Apologies were received and accepted from Cllr John Epton, Cllr Michelle Green, Cllr Mike Roe and Cllr Sue Smith.

02/01/23 Declarations of Interest from members on any items to be discussed:

Cllr B Barnes – Trustee Fidler and Laverack, volunteer for Stonebroom Community Volunteer Group, Stonebroom Food Pantry and the Holiday Activities and Food group. Cllr D Williamson – Trustee Fidler and Laverack. Cllr A Brown, Cllr J Bacon and Cllr G Mather – Management Committee of Shirland Village Hall.

Prior to the meeting Cllr A Brown, Cllr J Bacon and Cllr G Mather requested in writing a dispensation to allow them to participate in the discussion and vote for agenda item 12. A vote was taken with 4 Councillors for this action and 1 against.

03/01/23 To receive and approve requests for dispensations from members on matters in which they have a Disclosable Pecuniary Interest:

None.

04/01/23 To determine if any item on the agenda should be taken with the public excluded: Agenda item 29/01/23.

05/01/23 To consider for approval the minutes of the Parish Council Meeting held on Thursday 17th November 2022:

Cllr B Barnes proposed and Cllr H Liggett seconded that the minutes be approved.

06/01/23 Residents or public questions/comments (A period of not more than 15 minutes is allocated for members of the public and councillors to comment on any matter relating to the Parish):

A member of the public thanked the Parish Council for carrying out the footpath work at the Community Woodland. The gentleman spoke about the need for an enhanced road sweeping programme in Stonebroom and reported an issue with the surface of a public footpath in the village - the Clerk to report to Derbyshire County Council.

Cllr J Bacon reported that she had received a request for a Parish Council noticeboard at the bottom of Stonebroom near the entrance to the industrial estate – to be included on the February agenda.

Cllr A Lomax reported that he had met with a representative from Virgin Media back in December 2022 – the Clerk to contact Virgin Media for a progress update.

07/01/23 To consider the budget and the precept request for the 2023/24 financial year:

The proposed budget was circulated to Councillors prior to the meeting. A discussion was held and Cllr B Barnes proposed and Cllr H Liggett seconded that the budget be accepted with no increase to the precept and a request for £91247 be submitted to North East Derbyshire District Council. A vote was taken and this was unanimous with the exception of Cllr G Liggett who chose to abstain.

08/01/23 To consider the Cemetery fees for 2023:

Cllr H Liggett proposed, Cllr D Williamson seconded and it was unanimously agreed that the fees remain the same.

09/01/23 To consider the meeting dates for 2023:

Cllr A Brown proposed, Cllr J Bacon seconded and it was unanimously agreed that meetings be held on the third Thursday of each month with the exception of December.

10/01/23 To consider placing the order for the new play equipment at Stonebroom and Mickley:

Cllr A Brown proposed, Cllr H Liggett seconded and it was unanimously agreed to place the order for Stonebroom.

Cllr H Liggett proposed, Cllr G Mather seconded and it was unanimously agreed to place the order for Mickley.

11/01/23 To consider approving the draft version of the Neighbourhood Plan prior to the Regulation 14 consultation and approve expenditure which will be incurred during the consultation:

Deferred until a future meeting due to some Councillors needing more time to read the Plan.

12/01/23 To consider the quotations received for a new kitchen and appliances at Shirland Village Hall:

Cllr H Liggett proposed, Cllr D Williamson seconded and it was unanimously agreed to accept the quote from Alfreton Bespoke Carpentry and Joinery.

13/01/23 To consider the request for a litter bin by the bus shelter on Main Road Shirland:

Cllr A Brown proposed, Cllr H Liggett seconded and it was unanimously agreed that a request is made to North East Derbyshire District Council.

14/01/23 To consider the provision and installation of two additional War Memorials in the Parish:

Deferred until the February 2023 meeting.

15/01/23 To consider donating chairs to the Stonebroom Food Pantry:

Cllr A Lomax proposed, Cllr H Liggett seconded and it was unanimously agreed that the chairs be donated.

16/01/23 To consider the live streaming of meetings:

Deferred until a future meeting.

17/01/23 To consider the access to Stonebroom Woodland:

Cllr J Bacon proposed, Cllr D Williamson seconded and it was unanimously agreed to purchase a combination padlock.

18/01/23 To consider the quote received for work following the tree survey at Stonebroom Woodland:

Cllr A Brown proposed, Cllr J Bacon seconded and it was unanimously agreed that the quote be accepted providing that the Contractor is taking away all logs, branches etc.

19/01/23 To consider the renewal of the membership of the Peak and Northern Footpaths Society:

Cllr A Brown proposed, Cllr A Lomax seconded and it was unanimously agreed that the membership be renewed.

Cllr Cupit mentioned that North East Derbyshire District Council are still accepting comments on the High Street Stonebroom application.

Cllr Cupit also reported that further consultations are to be carried out in relation to the Stonebroom Community Governance Review.

Cllr H Liggett reported on a number of street cleansing issues.

Cllr H Liggett mentioned that the Chair of North East Derbyshire District Council is holding a Race Night on the 17th March 2023.

Cllr B Barnes expressed his thanks to the various groups in Stonebroom that carried out successful events last Summer, Halloween and Christmas.

Cllr J Bacon mentioned that she had attended the last meeting of the Food Pantry but was unaware of future meeting dates. Cllr Bacon said that she will be attending the next meeting of Stonebroom Community Centre.

The Chair reported on the recent anti-social behaviour at Shirland Playing Fields resulting in the picnic benches bring uprooted and turned upside down. Cllr Brown reported this to the Police.

Cllr Brown reported on the recent Annual General Meeting of the Shirland Village Hall Management Committee. Now the floor has been replaced plans are being made to decorate the Hall. Cllr Brown reported on the well-attended events that take place regularly at the Hall.

The Chair had attended a meeting of the Community of Shirland and Higham group where past and future events were discussed.
