01/06/21 To consider accepting apologies for absence:

05/06/21 To consider for approval the minutes of the Annual Parish Council Meeting held on Thursday 20th May 2021:

Cllr G Mather proposed and Cllr B Barnes seconded that the minutes be approved.

06/06/21 Residents or public questions/comments (A period of not more than 15 minutes is allocated for members of the public and councillors to comment on any matter relating to the Parish):

07/06/21 To consider the quotation received for the supply and installation of small goalposts at Stonebroom Sportsground:

Cllr D Williamson proposed and Cllr Barnes seconded that the goalposts are ordered from Soccertackle. This was unanimously agreed with the exception of Cllr G Liggett who chose to abstain.

08/06/21 To consider the request from Shirland PCC for a contribution from the Bell Acre fund towards the cost of servicing the clock at St Leonard's Church Shirland: Cllr S Smith proposed and Cllr H Liggett seconded that a donation of £200 is made from the Bell Acre Charity account. This was unanimously agreed with the exception of Cllr John Epton who could not vote on this item.

09/06/21 To consider the purchasing of a storage cabin for Mickley BMX track:

Cllr A Brown informed the meeting that a cabin has been kindly donated to the Club and should be on site soon. Cllr A Brown also mentioned that the Club have still not heard anything from

Derbyshire County Council regarding the possibility of an Youth Action Grant, Cllr H Liggett agreed to contact Cllr B Lewis.

10/06/21 To consider a response to the letter from Mark Fletcher MP regarding Stonebroom Sportsground:

A lengthy discussion was held regarding the content of the letter. It was unanimously agreed that the Clerk drafts a reply based on the discussion and circulates to Councillors for comments prior to sending.

The Clerk to contact Stonebroom FC requesting that they email the Parish Council regarding any problems in the future.

11/06/21 To consider the ordering of signage for Stonebroom Woodland Area and the email regarding this from the Headteacher of Stonebroom School:

Cllr D Williamson proposed and Cllr M Roe seconded that two signs are ordered. This was unanimously agreed with the exception of Cllr S Smith who could not vote on this item. It was also agreed that following the Headteachers email stating that the play equipment is not the responsibility of the school the Clerk writes to the School requesting that the cargo net is removed as soon as possible as it is considered dangerous.

The Clerk reported that to date no quotations have been received, Councillors to let the Clerk know of any suitable companies.
