Minutes of the Parish Council Meeting held in Higham Farm Hotel, Monday 17th September 2018 at 7pm.

The meeting was informed that the Annual General Meeting of Shirland Village Hall's Management Committee is to take place on 26th September 2018 at 7.30pm and the next Community Café will be held on 3rd October 2018 at 2pm. The lady asked whether a self-locking mechanism for the new door had been looked at even though at the moment it is working well with hirers calling once they are ready to leave – Cllr Barnes stated that the contractor will take a look but it is unlikely that an adaption can be made.

Two residents asked if they could sponsor a poppy on School Close and Quarry Lane outside the school; the Clerk to arrange this. Councillors complimented the gentlemen on their flower tubs this year.

8/09/18 Request for contribution towards the cost of servicing the clock at St Peter's Church Stonebroom

It was agreed that a S137 grant of £174 be awarded; Cllr S Smith approved, Cllr D Williamson seconded.

9/09/18 Continuing Items

a) "A Nation's Tribute" 11 November 2018: The Clerk is working with the two Churches to finalise the itinerary and advertise the event. The Church are still awaiting the faculty for the beacon, Cllr D Williamson agreed to call the solicitors that are dealing with this. A

- licence has been obtained from North East Derbyshire District Council to allow the charity collection to take place.
- **b)** British Legion Derbyshire 'Lamp Post Poppies' campaign: 130 poppies have been ordered and will be installed on lamp columns in the Parish.

Cllr C Cupit spoke about a recent site visit to High Street Stonebroom, Cllr B Lewis and representatives from the Highways department were in attendance to look at problems with the footways and trees. Cllr Cupit confirmed that this location is on the list for patching works to be carried out and North East Derbyshire District Council are to carry out a clean-up and road sweep.

12/09/18 Reports from Councillors on outside bodies

Cllr A Lomax informed the meeting that he is meeting with representatives from the two allotment sites on the 24 September 2018 at 7.15pm.

Cllr H Liggett confirmed that Derbyshire County Council's Rights of Way department is meeting with the landowner at Pit Lane following the query received at last month's meeting.

Cllr H Liggett has received a request for seating to be supplied at the play area adjacent to Shirland Village Hall.

Cllr B Barnes stated that he has reported the fly tipped gas cylinders over the bridge at Morton and the landowner has been contacted and asked to remove.

Cllr B Barnes has recently removed dead plants from the coal tub and the planters and carried out a small amount of planting.

Cllr B Barnes reported that work has been carried out on the roof tiles at Shirland Village Hall and the contractor is to return to adjust the fire door.

Cllr B Barnes reported the vandalism which has taken place at the play areas in Shirland and Stonebroom and mentioned that a new dog bin had been provided at the Forest School site.

Cllr B Barnes spoke about Derbyshire County Council's 'Snow warden' scheme: the Clerk to obtain further details.

Cllr H Liggett spoke about the possibility of First Responders and defibrillators in the Parish.
