239/16 Approval the minutes of the Parish Council Meeting held on the Monday 15 February 2016

The minutes were accepted as a true record, Cllr A Brown proposed, Cllr S Jones seconded.

240/16 Apologies for absence

Apologies received and accepted from District Councillor C Cupitt and Assistant Clerk Tom Tait.

241/16 Declarations of interest from members on any items to be discussed

Cllr A Brown declared an interest in matters relating to Shirland Village Hall.

242/16 Disclosable Pecuniary Interest

Cllr A Brown declared an interest in matters relating to Shirland Village Hall.

243/16 To determine if any items should be taken with the public excluded

Cllr Barnes requested item 12 should be taken with the public excluded. AGREED.

244/16 Police Items

PCSO presented the crime and anti-social report for February 2016.

245/16 Public Participation (Timed at 15 minutes)

The MAT worker gave an overview of the work carried out by Derbyshire County Council with the 11-19 years age group. Currently learning about issues in the Parish and working to build rapport and committed to working in the area. She commented on the outstanding Youth Project at Stonebroom.

Neighbourhood watch – a member of the public reported that the last meeting was not well attended by the public and re-iterated that people must report any suspicious behaviour.

Two additional Planters were requested by members of the public which, strategically placed, will further help with poor parking at Stonebroom School.

246/16 Co-option to the Parish Council

Following the advertising of vacancies within the Council Cllr Barnes requested that Mr Sam Davis be considered as a co-opted member. Mr Davis has already served on the Parish council and he felt his input would be invaluable. Following a unanimous vote that Mr Davis be co-opted onto the Council he was invited to join the Parish Council.

248/16 PCSO request for funding

The council has been asked to help fund activities for the 7-11 year age group during the school holidays. This scheme has been successful in neighbouring parishes. It was AGREED to fund this on a drawdown basis to a maximum of \pounds 1,000 on condition that the County Councillor, Rykneld Homes and the Police Crime Commissioner are also asked to contribute.

The Risk Assessment highlighted areas which Council may need to address it was therefore AGREED to engage in the services of a Health and Safety advisor to ensure compliance with Health and Safety law.

It was AGREED that Turning Leaves be re-appointed as contractor for mowing for one year.

254/16 Adoption of Telephone Kiosk, Shirland

No further progress – Cllr Brown suggested again that this should be an information point.

256/16 Shirland Village Hall Lease

Cllr Barnes asked to attend the next meeting of the Management Committee to discuss.

The Clerk to write to Mr L Pell to thank him for his dedication to the Cemetery.

Work as previously agreed to be carried out on Tuesday 29 March 2016.

259/16 Village Hall Loans

Shirland Village Hall up to date to 31 January 2016. Mickley Hall Committee has yet to meet.

260/16 Report from County Councillor

Cllr Lewis reported that despite taking to highest level, work on Highways and Pavements is falling short of expectations. This is ongoing across the County and he is extremely

disappointed. Despite this a recent customer Satisfaction Survey showed overall that Council Services are viewed as of high quality.

Cllr Barnes reported that the transitional grant funding we receive will cease over the next three years. Council must be mindful of this each year when setting the precept.
